TERMS & CONDITIONS OF ENTRY

Entry

Information on how to enter and other details form part of these terms and conditions. If there is a conflict between the information on how to enter and these terms and conditions, these terms and conditions will prevail.

- Entry is free.
- Contestants must check in at the registration area on the day, or via the online form, between 11:30 am and 1:15 pm to complete the registration process. Entrants who do not complete this process will be disqualified.
- Entry is open only to attendees of MyRacehorse Counties Cup Day at Pukekohe Park on Saturday 22 November 2025.
- All entrants must be aged 18 years or older.
- Auckland Thoroughbred Racing (ATR) reserves the right to request proof of age.
- Entrants may only enter in a personal capacity. Entries on behalf of a third party, including commercial enterprises, will result in disqualification.
- Outfits must not commercially promote a brand, store, or designer. Breaches will result in disqualification (at ATR's discretion).
- Entrants must not receive any payment or benefit from third parties for participating.
- Contestants must not be dressed or styled by a designer or milliner. Breaches will result in disqualification (at ATR's discretion).
- Those professionally involved in producing fashion, millinery, or similar, are ineligible to enter if their role is deemed to provide an advantage (at ATR's discretion).
- ATR retains rights to all photos and footage taken of entrants for promotional purposes.
- By entering, participants consent to receiving information from ATR and those sponsors listed under "Prizes". Entry implies consent for promotional activities related to ATR and sponsors.
- Entrants must uphold the integrity of the event and act in good faith when referencing ATR, the competition, or other participants and stakeholders.
- Disparaging or derogatory comments about ATR, the competition, or other participants and stakeholders will result in disqualification from this and all future ATR competitions.
- These terms & conditions take precedence over any conflicting information.
- By entering, contestants agree to be bound by these terms & conditions.

Winners

 - Belinda Green Millinery Maiden (open to all contestants)
- There is a qualification pathway associated with this event with the Caci Pukekohe Womenswear Award winner qualifying for The Ned Prix de Fashion at Ellerslie on Champions Day, 7 March 2026.
 - In the event the Caci Pukekohe Womenswear Award winner has already prequalified for The Ned Prix de Fashion, the second placegetter will instead qualify (and so forth)
- Announcements will be made via public address. Contestants must appear 10 minutes before the start time of heats, finals, or presentations, or risk disqualification.
- ATR is not responsible for any contestant missing competition announcements (e.g. due to missed call, txt message not received, inaudible PA or timing); entrants must ensure they are present and attentive.
- Prizes are awarded to the wearer of the winning outfit and are not transferable.
- Winners may be required for up to 30 minutes after the presentation for photos and media.
- Winners agree to participate in promotional activities for up to 12 months after the event.
- Judges' decisions are final and binding. No correspondence will be entered into.
